These are just some of the ways God blessed the ministry of MB Foundation, and some of the ways we were blessed by our involvement! Any team member here would have a slightly different list of highlights.


I invite you to read this annual report for more information on the items I highlighted, and much, much more.

\$200,000,000 in Assets

Nearly 150 years ago the Mennonite Brethren movement landed in the United States. This committed group of immigrants had a heart for sharing Jesus with the world and wanted to pool their resources to fund global missions. As early as 1880, they started a fund for this very purpose. From those early seeds of sharing and stewardship, the ministry of MB Foundation began to take root. Over the decades since, those seeds sprouted and grew and in 2018 MB Foundation reached a significant milestone, topping over \$200 million in assets.



While growth has been steady over the years, assets grew by 12% in 2018. The previous two years assets grew by less than 3% each year. There were several reasons we saw a significant bump in 2018:

- A family foundation selected MB Foundation to manage their assets.
 Assets will transfer to MB Foundation over several years.
- Investors from our MB family invested over \$8 million in new money in Certificates; an increase of 9.3%.
- Donors contributed over \$25 million in real estate, commodities, stocks and other property to be managed and eventually gifted to the ministries of their choosing!

"We celebrate a generous God during this season of growth," said Jon C. Wiebe, President & CEO. "We expected to pass this milestone one day, but God blessed us to do so in 2018. I imagine this is more than our founders thought possible. May it be a lesson to us as to how generosity can plant seeds for a future harvest."








\$4,766,207

On December 21, 2017, Randy and Max Steinert formally decided to place the Steinert Family Foundation (SFF) under MB Foundation's management. SFF is a private foundation created by Randy and Max's parents, Marvin and Nadene Steinert. What led the Steinerts to this enormous decision includes not only a long history with MB Foundation, but also a strong belief in the importance of ministry and a dedication to the Mennonite Brethren family.

For Randy, the Foundation's commitment to Mennonite Brethren churches and

its dedication to stewardship education was impressive. "People need to know how to give and how to give effectively and how to manage their finances and how to pass that on to the next generation. I think MB Foundation has developed a system for the Mennonite Brethren community that promotes good stewardship."

MB Foundation's various giving vehicles "have been just a real blessing to us as a family because we are able to give and yet not pay so many taxes on the assets that have appreciated," Randy said.

Complex Gifts Made Easy



It was our privilege in 2018 to assist a couple with the largest single gift from a living donor in the history of MB Foundation! This couple has reached a point in their life where they are downsizing and working their way out of real estate property management.

They wanted to liquidate a 28 unit apartment complex and a 22 unit complex valued at \$4,595,000. MB Foundation presented a plan for liquidation that would allow them to discontinue the responsibilities of property management, establish an income for life, and provide for charity at their death. MB Foundation facilitated the gift, managed the property, negotiated the sale, and processed the complete transaction. Now we manage the investments and provide an income stream to the couple. Someday, we will facilitate the distribution to charity, according to their instructions. A complex gift was made easy. A true win-win for the couple and the ministries they love.



Neighborhood Church - Visalia, CA

Neighborhood Church is located in Visalia, CA started in 1948 and has grown to see an average attendance of 1,600 on a Sunday morning. Neighborhood partnered with MB Foundation to expand their church campus to better accommodate their growth. The expansion project resulted in additional space for ministry and offices, additional parking, shade structures and renovations to their current space. Included in the expansion is 10,000 square feet of kids ministry space to better accommodate the 800 kids they host on Sunday morning. The grand opening was held on September 23, 2018.
